

Program Requirements

Eligibility Guidelines

- Must live in the United States.
- 19 years of age and older.
- Have no health insurance or prescription drug coverage for vaccines.
- Meet financial guidelines.

Application Process

- Application and financial information is faxed to pharmaceutical company for approval.
- Approval is usually received in 60 minutes and vaccine will be administered once approved.
- A new application may be required for each visit.

Pfizer Vaccines**

Pevnar13 vaccine available to:

- Adults 19-64 years of age with specific medical conditions.
- Adults 65 years of age and older.



Must have no insurance or prescription coverage for Pevnar 13.

Pfizer Income Guidelines

- Total Monthly Income before taxes:
 - 1 person– less than \$4,047
 - 2 people– less than \$5,487
 - 3 people– less than \$6,927
 - 4 people– less than \$8,367
 - 5 people– less than \$9,807
- No income documentation needed.

Merck Income Guidelines

- Household Annual Income below:
 - \$ 48,560 per individual
 - \$ 65,840 per couple
 - \$ 100,400 family of four
- No income documentation needed.
- May qualify due to financial or medical hardship even with insurance.

- Hepatitis A
- Hepatitis B
- Shingrix (Shingles)
- Tdap (tetanus, diphtheria & pertussis)

GSK Income Guidelines

- Household Monthly Income:
 - \$ 2,529.17 per individual
 - \$ 3,429.17 family of 2
 - \$ 4,329.17 family of 3
 - \$ 5,229.17 family of 4

(add \$900 for each additional person)
- No income documentation needed. Program will complete automated validation of income.
- Applications are normally processed within 2 business days.
For immediate requests providers can call for verbal processing of eligibility based on patient income and household size.
