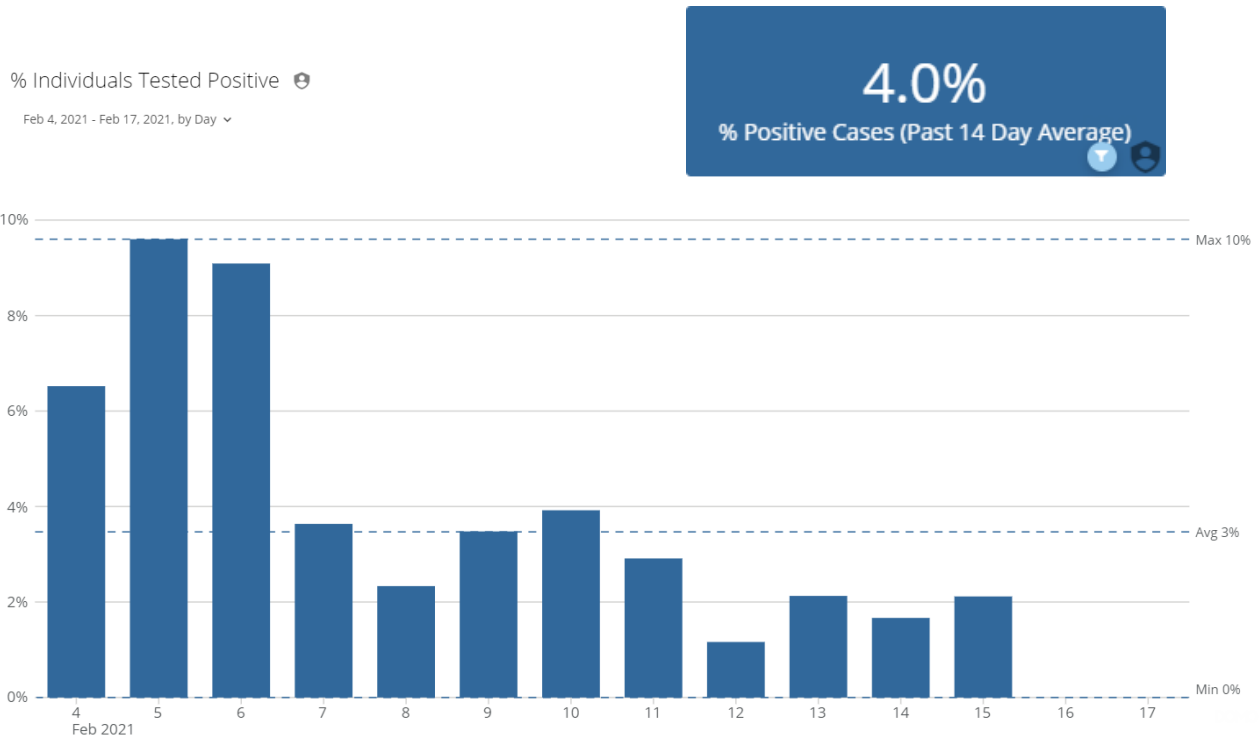
COVID-19 Joint Information Center Update

Data Snapshot (as of 10:00am)

- 330,434 total lab-confirmed cases of COVID-19 in Iowa (02/17/2021).
 - 4,933 total lab-confirmed cases of COVID-19 in Cerro Gordo (02/17/2021).
 - 4,629 total recovered in Cerro Gordo (02/17/2021).
 - 225 total active cases in Cerro Gordo (02/17/2021).
- 5,306 deaths in Iowa (02/17/2021).
 - 79 deaths in Cerro Gordo (02/17/2021).

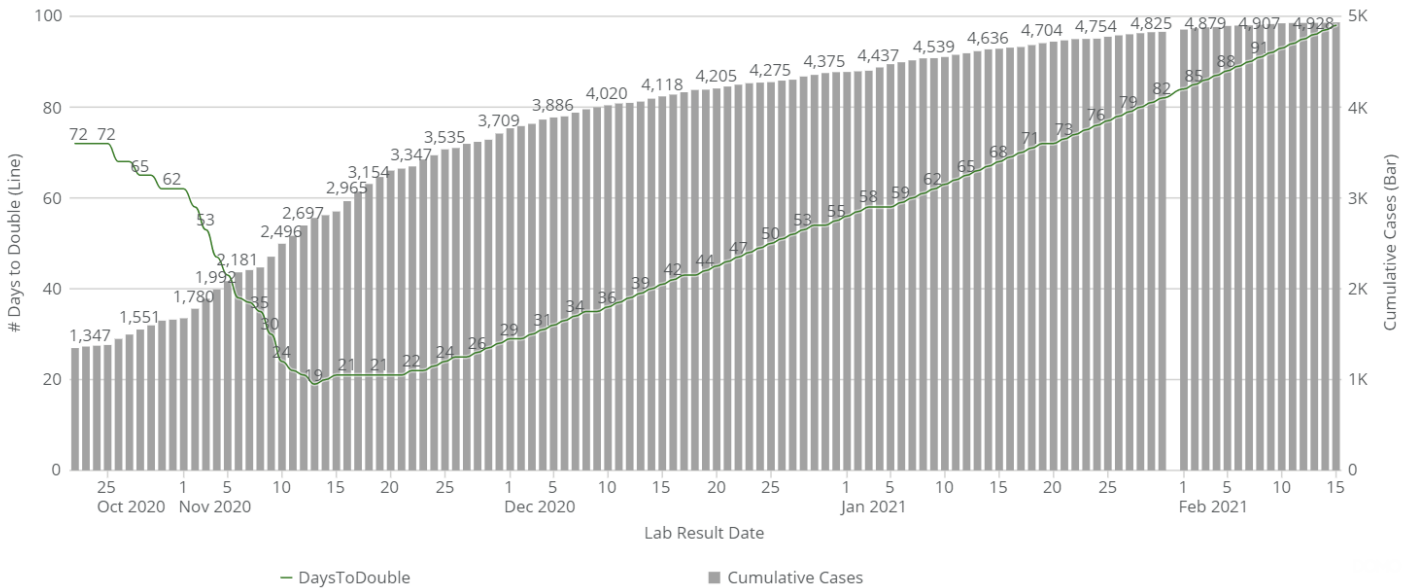


Days to Double
